Bancroft Welcomes New Chief Development Officer

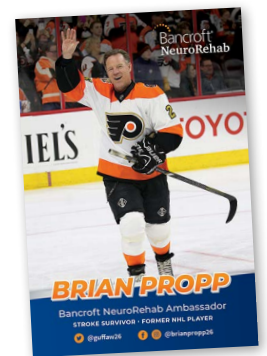

“She loves the water,” says Barry Bodine, proud dad of Kaylee, who attends The Bancroft School in Mount Laurel. “She’s always been attracted to the ocean and how it makes her feel.”

Kaylee, 12, was diagnosed with autism as a toddler but her behaviors became apparent when she was around 9 months old. She wasn’t reaching her milestones – crawling, babbling, and walking – and needed the sensation of banging her body on things.

“We began searching for resources and supports to help Kaylee overcome her challenges and then we found Bancroft,” said Barry.

Working with their school district, Kaylee entered The Bancroft School Early Education Program when she was 6 years old. She has been thriving at Bancroft ever since and now enjoys her classes on the transformational Bancroft Raymond & Joanne Welsh Campus.



“Weekends are tough for us because she wants to be back at school so much,” said Barry.

Kaylee loves to utilize the space in the hallways and can often be seen walking and even skipping around campus. But her favorite part of the new campus is time spent on swim lessons and sensory play in Matthew’s Pool.

“She knows when it’s swim day, her most favorite day, and even though she can’t verbally tell me, her smile when I ask her about swimming is all it takes to tell me she’s truly in a happy place,” said Barry. “With the right tools, Kaylee and kids like her can learn to overcome even their greatest obstacles.”

Sadly, drowning is one of the leading causes of death for children in the United States and is the number one cause of death for children with autism. Bancroft wants every child to be able to enjoy the things they love, regardless of their abilities, and wants them to do it safely. The Bancroft swim instructors are trained to work with children with special needs and meet each child at their level to help build their skills. The program is also an opportunity for the participants to have fun and be active. Bancroft strives to expand this program across the organization through greater donor investment and partnerships.

ONE Step at a Time

DREW HERRINGTON

In 2012, Drew Herrington was the picture of health. Climbing the ladder as a construction project manager and strengthening his relationship with his longtime girlfriend Katie, the 32-year-old was living a life that was just beginning to take off.

As they often did, Drew and Katie were chatting on the phone while Drew drove home from work. During their conversation, Drew's speech became jumbled and unrecognizable. Turns out, he was having a stroke which would leave him unable to walk or speak. The stroke threatened everything Drew had been building toward.

At first, Drew could give a simple thumbs up or down as his sole method of communication, but his family wasn't sure he could understand them. It seemed everything Drew had once envisioned – from an exciting and prosperous career to marrying and starting a family with Katie – would never become a reality. The first year of recovery was all about celebrating the small milestones. "Every new word he learned was a celebration for us," Katie recalls.

After that first year, Drew and Katie knew they needed to seek more help to continue on this road to recovery. Once referred to Bancroft NeuroRehab, Drew quickly filled his days with outpatient therapies. From physical therapy to regain balance and mobility, to occupational therapy to work on everyday tasks, to speech therapy, which was used to combat Drew's biggest challenge: Aphasia.

"Aphasia is a condition that affects a person's ability to find the right words. Cognitive abilities remain intact, but the person can't find the words to express what they're thinking," said Michelle Valente, Rehabilitation Supervisor at Bancroft NeuroRehab,

who has been Drew's speech therapist since he arrived at BNR. Speech therapy helps Drew, and others, set strategies to adjust to their 'new normal,' allowing them to reclaim the things they love.

No matter the challenge, Drew and Katie faced it together – along with the NeuroRehab team. There, Drew took his first independent steps and the pair started to see a glimmer of hope and the future they had always planned. These steps led to greater mobility and a reimagined life. Along the way, Drew's strong-willed attitude, combined with his deep familial and therapeutic support, led to the many strides made in the seven years since his stroke.

Today, Katie and Drew are partners in life and in business. Drew began his own construction company – Herrington Homes – and married Katie in 2016. In early 2018, the two celebrated their biggest milestone yet and welcomed twin daughters Claire and Liv into the world. As he approaches his 40th birthday, Drew has a new lease on life. He's entered a new phase of recovery as he was just discharged from speech therapy at Bancroft NeuroRehab, having met goals that once felt impossible.

"He's met the goals we and his treatment team set and I'm so proud of what he's achieved," Katie said. "I don't even know where we would be without his therapies. We've loved the support we have received from Bancroft NeuroRehab. Everyone there feels like family."



ONE Home Sweet Home

When Leslie and Rob Bradley found out they were having twins, they were excited at the thought of their soon-to-be family of five. They knew they would have their hands full with a 3-year-old and twins on the way, but they were excited to expand their family.

Lauren and Katie bounced into the world growing and thriving, and as they were just beginning to acclimate to their new life, their older brother, Jackson, was diagnosed with autism.

Jackson's diagnosis allowed the family to be keenly aware of milestones to watch closely for with regards to the girls' development. It wasn't long after that they noticed Lauren was falling behind, so they had Lauren evaluated as well.

"Having the diagnosis allowed us to start very early for Lauren to receive intensive early intervention," Leslie said. "Even at 18 months, we knew she was going to be more severe than her brother, but we were going to do everything we could to get her the support she needed."

After early intervention, Lauren began her education at a private school near the Bradleys' Pennsylvania home, where she did very well, eventually beginning to speak when she was 6 years old. She made steady progress over the next few years but as she approached her teenage years, Lauren began to develop aggressive behaviors that became difficult to manage. The family needed a more intensive program designed to meet Lauren's changing needs. After exploring several programs in Pennsylvania and New Jersey, the Bradleys found Bancroft.

Lauren has blossomed in her home on the Welsh Campus – becoming more independent and developing friendships.



When Lauren began attending classes at The Bancroft School in 2017, it quickly became clear that Bancroft's individualized programming was helping Lauren become more focused in the classroom – and her family believed she could benefit even more from a residential program. Lauren was accepted into the pediatric residential program in 2018.

Lauren has blossomed in her home on the Welsh Campus – becoming more independent and developing friendships.

"It makes us feel very good about where she is, how she's being cared for, and the skills she's learning," Leslie says.

"It's been a joy to have Lauren come home on weekends and to become a viable member of the family again," Rob said. "One of the things I'm most looking forward to is continuing to see Lauren grow and become even more independent."

WAWA, RAVITZ FAMILY MARKETS AND BANCROFT

Wawa's relationship with Bancroft started decades ago when Bancroft opened the Sweet Success store at its iconic Haddonfield Campus. The store was a cornerstone of the original job training program created for The Bancroft School students. When Bancroft's new Raymond & Joanne Welsh Campus at Mount Laurel was being planned, we wanted to recreate this wonderful job program for our students, but we wanted to make it bigger and more robust. That's when The Ravitz Family Foundation of Ravitz ShopRite and The Wawa Foundation and Wawa joined forces with Bancroft to create one store with a grand purpose.

Together, we created a sparkling new storefront and corresponding training classroom at the Bancroft Raymond & Joanne Welsh Campus. As graduates from Bancroft's employment programs may find themselves working in a Wawa or Ravitz ShopRite store one day, they receive hands-on training by stocking, cashiering and helping customers at the fully functioning store right on campus.

Over the past year, the Adult Employment Program has placed 89 adults with intellectual and developmental disabilities in jobs and supported

another 29 in current positions. Michael Smith and Kristen Heiser are two individuals with disabilities who have benefited from the Adult Employment Program and who take pride in their work at Wawa and the Ravitz ShopRite respectively. We thank Wawa, The Wawa Foundation and Ravitz ShopRite for their commitment to Bancroft's Adult Employment Program.

ONE Life-Changing Pup

Spring 2019 was certainly the season of Seamus – our Canine Assisted Therapy (CAT) dog – and Dr. Carolyn Tassini.

Together, at Bancroft NeuroRehab’s Resnick Center, they have helped patients suffering from brain injury work to strengthen their occupational, physical and cognitive functioning and to enhance their independence.

From playing tug-of-war and focusing on equilibrium and balance, leashed walks that improve endurance and stamina, to the simple act of fur-brushing for grip and mobility, Seamus has helped many individuals at BNR over the last five years.



In 2019, Seamus turned 10, which is his mandated retirement age. Looking at the costs of being matched with a new Canine Assisted Therapy dog, training, housing, visits to the vet and other necessary steps, Dr. Tassini and the staff at Bancroft NeuroRehab started with a simple bake sale to raise funds. What started as a small, grass-roots fundraiser quickly bloomed into an online campaign, with a generous \$5,000 lead gift from J&J Snack Foods.

Wanting to help usher him into retirement, the Student Council at The Bancroft School waged a Penny War across classrooms. Students collected

pennies and other silver coins to compete to raise the most money. The Penny Wars took place over the course of the last two weeks of the school year and raised over \$400! The dedication of this group of student leaders did not go unnoticed and Seamus visited them to present a special thank you card.



More than 100 new and returning donors helped raise over \$21,000 to help Seamus retire and provide crucial funding to help continue this important program. In late July, Dr. Tassini and the staff at the Resnick Center welcomed Dave, their new CAT dog. Dave certainly has the energy of a younger pup and is making fast friends with the BNR clients, enabling them to work harder, longer, and push toward a strong rehabilitation.

Weekend Warriors

The program provides encouragement and incentive for our Direct Support Professionals to generate creative and fun experiences both onsite and off. 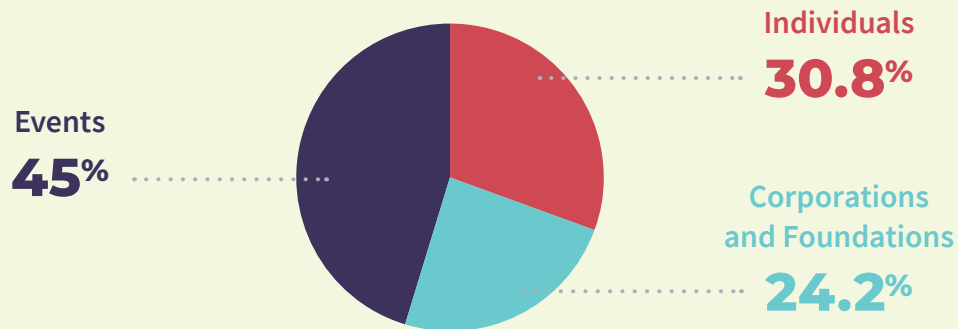

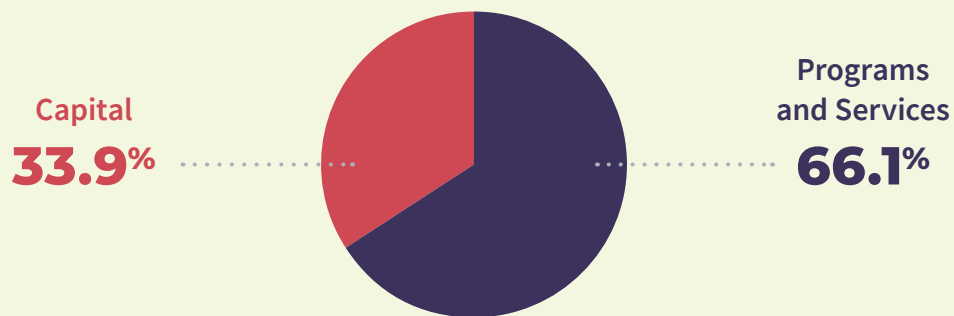
