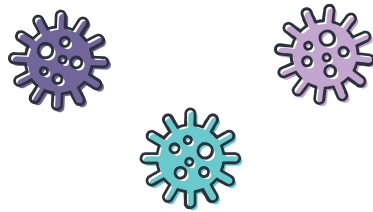

# Fiscal Year 2021 in Review

## Bancroft Receives Over \$3.6M in COVID-19 Relief Grant Funding

The emergence of the Delta variant has underscored the importance of philanthropic support as we navigate continued challenges. Support from individual donors, local businesses, fundraising events and grants has been vital to offset the unexpected and increased expenses that we continue to face daily. In fiscal year 2021, we successfully forged new relationships with funders and deepened partnerships with existing ones. In total, Bancroft was awarded 19 grants from corporate and foundation partners and federal and state relief funds, providing more than \$3.6 million to offset expenses related to the pandemic.



## Five-Year Strategic Planning Process Initiated

Bancroft has grown significantly over the last 15 years; in fact, revenue grew by 155 percent from fiscal year 2004 to fiscal year 2020. To continue this momentum, the organization is developing a five-year strategic plan (2022-2026) to achieve an additional \$100 million in growth: \$10 million generated from new partnerships and programs, \$20 million from organic growth and \$70 million from mergers and acquisitions. It is through this process that Bancroft is working to provide the highest quality services for the many families who need us today and in the years to come.

## Planning for the Future with the Facilities Master Plan

In partnership with KSS Architects, Bancroft has undergone a comprehensive analysis of our current space and developed a facilities strategy that aligns with Bancroft's greater organizational goals. These findings enabled the creation of a Facilities Master Plan that outlines the most effective use of existing facilities and opportunities for future growth and expansion. Two immediate priorities will be completed in fiscal year 2022: Moving the New Jersey Adult Day and Employment Programs to the Lebensfeld Building in Cherry Hill, NJ, and opening a new Human Resources and Organizational Development & Learning satellite site in Moorestown, NJ.





## Bancroft's Preschool & Early Education Program Has Expanded

Bancroft's Preschool & Early Education Program moved to Moorestown, NJ, and has increased its capacity to 65 students, ages 3 to 11. The new location offers expanded opportunities for academic, social and physical development and provides direct access to behavioral, medical and emotional supports to maximize each student's potential. The autism-friendly design was informed by the success of the Raymond & Joanne Welsh Campus and will better meet the distinct needs of Bancroft's youngest learners. Additionally, it features an enhanced outdoor recreation space, Uncle David's Playground, with an adaptive playground to support structured activities and encourage exploration, play and socialization that was generously funded by the Pincus Family Foundation.



## Diversity, Equity & Inclusion Initiatives Update

Diversity, Equity & Inclusion (DE&I) remains at the forefront of the organization's collective consciousness. Bancroft's DE&I Council and Steering Committee finalized the DE&I Vision Statement and Strategic Plan, which details specific actions identified that are being implemented to make the organization even more respectful and inclusive and to ensure the future sustainability of these initiatives. Some of the accomplishments to date include: hosting a Cultural & Courageous Conversations series for staff; developing required training for all employees; engaging with a consultant to increase diverse sourcing strategies for candidates for leadership positions; and creating communications on DE&I activities, events and related resources.

## Bancroft Welcomes New Vice President of Finance

Rachel Bednarczyk, CPA, joined Bancroft in April 2021 and is responsible for maintaining the overall integrity of the organization's financial accounting practices and financial reporting structure. She brings more than 15 years of experience in accounting, financial management and leadership to Bancroft. Most recently, she was the Corporate Controller for Lutheran Social Ministries of New Jersey, a \$75 million nonprofit organization.

Prior to Lutheran Social Ministries, Rachel provided audit services for various clients primarily focusing on healthcare and nonprofit organizations. She is a certified public accountant in Pennsylvania and earned her Bachelor of Science degree in accounting from Rowan University.

## Matt's Keys to Success

Matt Collura is impressive. A three-sport athlete and captain in high school, he boasted a four-and-a half-minute mile on the track. This competitive drive and dedication followed him through his academic achievements: a bachelor's degree in biochemistry from Boston College and a master's in architecture from the New Jersey Institute of Technology. He's also an avid writer filled with wit, insight and honesty. It could go without saying: Matt is an earnest student of anything he chooses to do.

On March 9, 2011, Matt set out for the mountains with his snowboard, eager to spend the day on the slopes. Through a harrowing accident, he sustained a traumatic brain injury (TBI) and was in a coma for over two weeks, leaving him hospitalized for four months. Subsequently, Matt and his family chose Bancroft NeuroRehab (BNR) for his residential care and day program services.



Each year, an estimated 1.5 million Americans sustain a TBI, including an average of 13,500 New Jersey residents. The outcome of these injuries vary and many individuals require a variety of therapies and programs to help them rebound from injury and discover their future.

In the days following the accident, Matt's doctors said he may never walk again. Matt's dedication and tenacity were traits that his friends and family knew well. "If anyone can make it through this, it's Matt," was commonly uttered. **Matt has met each challenge with a positive attitude and indomitable will to achieve every goal.** Working with the team at BNR, Matt has learned to walk with a platform walker, his speech has grown clearer and he's making strides toward his goal of independent living.



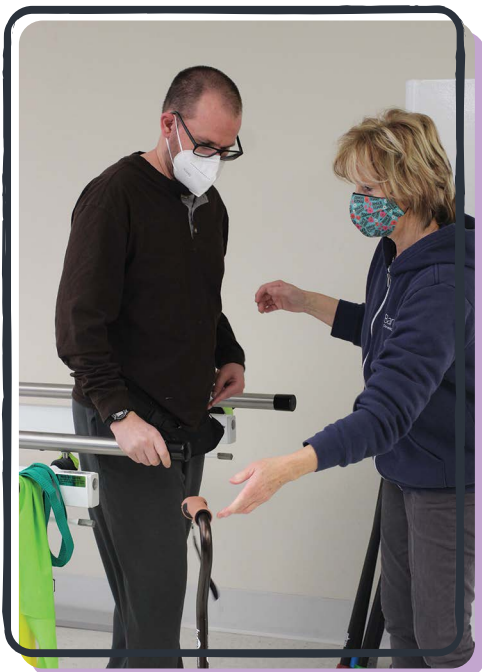

BNR takes a transdisciplinary approach to recovery. Matt's speech, occupational, physical and vocational therapists work with many others on his care team and focus on person-centered care. This ensures he is able to continue to grow and function at his greatest potential. Simply put, they work together so Matt will always live his best life. This holistic approach works with each individual client to best realize goals. Most recently, Matt set two: to work and live more independently. Matt and his team are diligently working to require a lower level of assistance and supervision so he can achieve those goals.

Matt's determination and drive as an athlete and student shines at Bancroft NeuroRehab. He resides in a group home with four other BNR clients and actively participates in daily chores, such as meal planning and preparation, cleaning and laundry. He also serves as a cheerleader and confidant for so many others, sharing his positive attitude to help everyone along their journey.

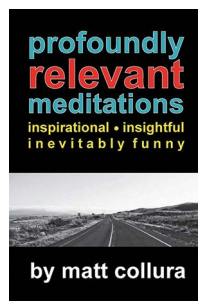

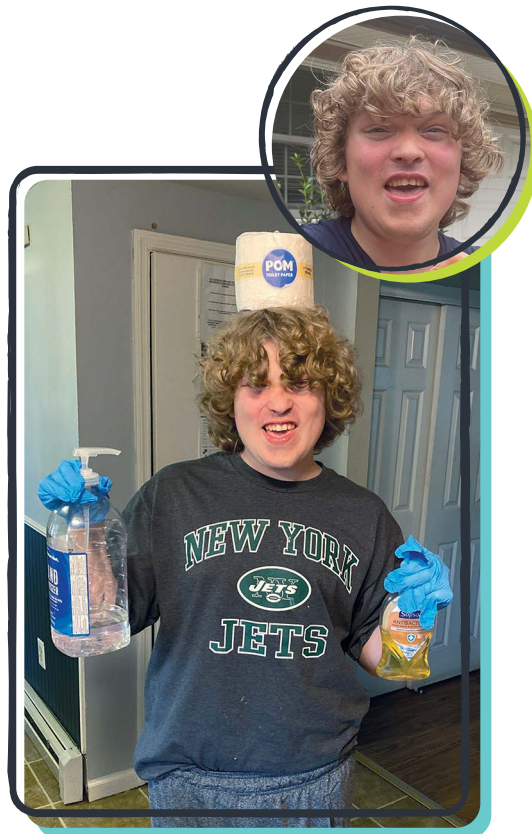

# James' Journey to His New Home

All a parent ever wants for their child is for them to be happy, safe and taken care of. For Terris and John Garbarini, this is especially important. Their son James loves going out to restaurants to meet and talk to new people. He loves it so much, in fact, that he would sometimes leave their house without anyone knowing and go sit at his favorite restaurant in his hometown of Manasquan, NJ.

Although James is a very cheerful and loving young man, his parents knew his challenging and self-injurious behaviors would require 24/7 care. In November 2019, 18-year-old James was enrolled at The Bancroft School and moved into a group home in the Children's Community Program in Cherry Hill. It's been difficult for Terris and John to live away from their son, but **they know Bancroft is a place where he will be safe and receive the essential care he needs.**

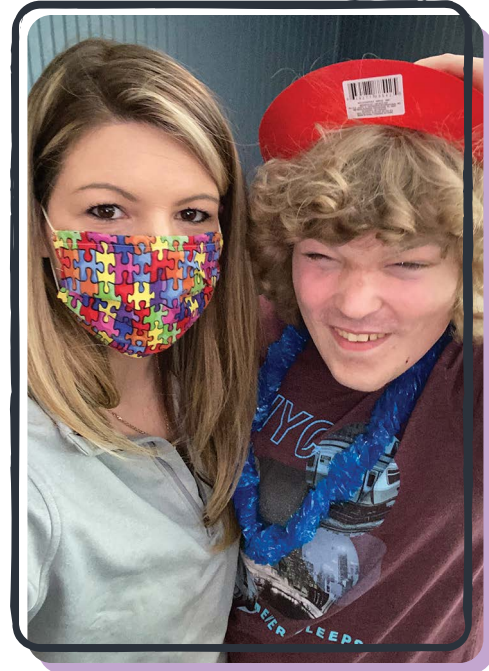


Bancroft's children's group homes, including the one where James lives, give children and young adults a place to live more independently while continuing to build upon the necessary life, social and cognitive skills they have developed. The Children's Community Program incorporates a focus on each child's development and is integrated with the curriculum at The Bancroft School.

Residents live in well-maintained single-family homes where they participate in meal preparation and daily chores and care for themselves and their belongings. Staff supervision is in place 24/7 in a safe and comfortable home environment where they get to engage with peers and the community. Each child has his or her own room – a space to call their own.

Today, 20-year-old James is as joyful as ever and has never once tried to leave his group home. He is very verbal and loves to talk to and be with people. Although sometimes he can have a few behavioral issues in the classroom at The Bancroft School, his language and sentence use has improved tremendously!

James has found a special love for his teachers and the other caregivers around him. He always talks about his teachers and even likes to print out pictures of them to hang in his room at home. One of his favorite things to do is visit his former teacher Stephanie. His teachers have even learned that James loves to be rewarded for his good behavior with these special visits.



James has a contagious smile and it is clear that he has left a lasting impact on those around him. One program manager stated, “James is an amazing child! I love him so much and he truly has a special place in my heart.”

The Bancroft School and the Community Residential Program work together to make sure James is living his best life and is given every opportunity to succeed. Terris and John feel that the Bancroft team really cares: “It is very clear that this is not just a job. They are focused on the children and want to make a difference.”

# Victoria's Path to the Ultimate Achievement

Victoria Hill recently celebrated her 31<sup>st</sup> birthday in August. She loves to color intricate designs on her tablet as a way to unwind and cope with the difficulties that sometimes come with everyday life. As often as possible, she likes to call and talk with her father or one of her three siblings. She looks most forward to her visits home and loves making her family proud. Victoria has many short- and long-term aspirations, the most exciting of which is her current goal to be able to live more independently so she can move closer to her aging father.

In 2019, Victoria resided in an adult group home operated by Bellwether Behavioral Health in Gloucester County, New Jersey.

When Bancroft acquired seven Bellwether group homes and one Swedesboro-based adult day program in July 2019, Victoria transitioned to living and learning with Bancroft. The last two years have been filled with progress throughout the Gloucester Program and Victoria's story is no different – her strides forward have been hard-won and certainly impressive.

Before Bancroft, Victoria had a history of intense and frequent behaviors that at times became dangerous, even involving law enforcement. Compounded with learning struggles, Victoria was bounced around various residential settings with many providers unsure of how to help. Victoria needed to find the right fit to receive the support she needed so she could continue to grow and realize her very best life. Her transition to Bancroft was rocky but with the help of ABA Specialist Colleen Mosco and other members of her care team, Victoria was able to stabilize through a variety of supportive steps. **Victoria is now her own advocate.**

At Bancroft, Victoria is able to work on her goal of living more independently. She cooks, cleans and does her own laundry with little guidance from the team at her group home. She even helps the others that live with her! She worked with a Bancroft employment specialist and acquired employment at a local fast-food restaurant. This alone was a tireless effort through many mock interviews and participating in other interviews virtually. **Victoria is also an active participant in her treatment plan.** She works closely with her case manager, supports coordinator and the many Bancroft personnel who work with her at her home, as well as the Gloucester Adult Day Program. She manages these meetings each week by using the e-calendar on her cell phone and continues to hone her independent living skills.

Victoria also has a lot of hobbies. She loves to watch football, sporting her Carolina Panthers jersey on Sundays. She always loves to be pampered and never turns down getting a manicure or a new haircut. She also loves trying on and wearing different wigs or buying a new charm for her bracelet.



Once Victoria is able to reach her goal of living more independently, she plans to pursue her GED, as she was not able to finish high school. This long-term goal is the ultimate achievement for Victoria and is incredibly important to her. She looks forward to hanging her diploma amongst those of her siblings on the walls of her father's house. She says she wants to make her family proud and she has certainly already done so.

He is focused, dedicated, kind and thoughtful. In speaking with the Fox family and various Bancroft team members, it is clear that Cody is also incredibly loved and well cared for.

While the path to Bancroft was a bumpy, hard-fought journey, it was all worth it. Cody has now been a resident and participant in the Lakeside Day Program for almost eight years and he is much happier and more independent than he was before he arrived.

Before coming to Bancroft, Cody was very dependent on those around him, especially his dad Alan. Cody followed him everywhere; his shadow. Any separation of Alan and Cody typically resulted in difficult displays of negative behaviors and outbursts. When Alan first visited Bancroft's Lakeside Campus in picturesque Woodstown, NJ, it all just clicked. Together, all members of the Fox family knew that this was where Cody needed to be.

The campus is a space that allows him to quickly and easily access nature with a lot of room for outdoor activities. One of his favorite pastimes is taking photos of the local habitat and he often requests new batteries for his camera because he uses it so frequently. **Since moving in, Cody has continued to grow and thrive under the supportive guidance of the team at Lakeside. His mom Connie notes that Lakeside is "exactly where he needs to be."**

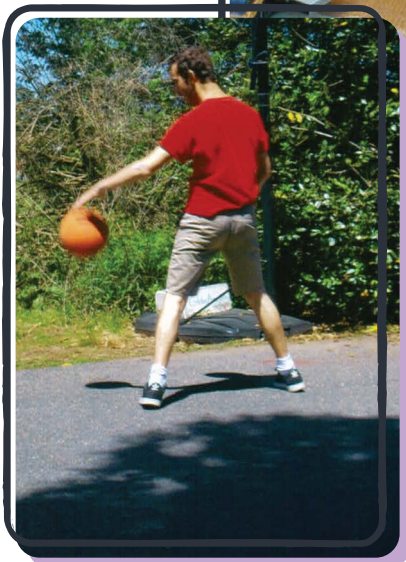
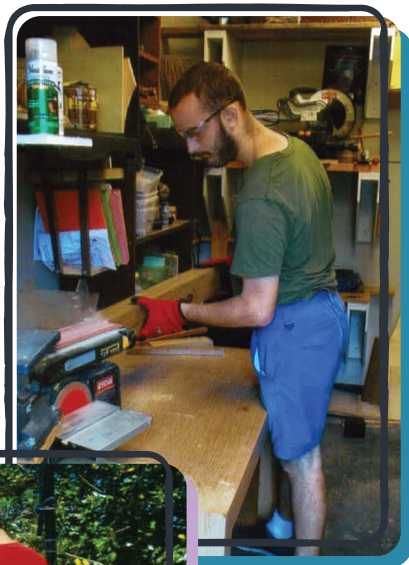
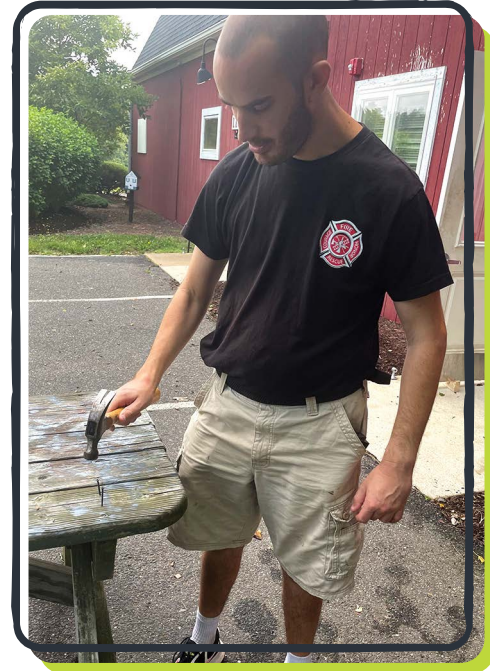

On any given day across the expansive Lakeside Campus, Cody and his good friend and roommate Kevin can typically be found with the Facilities crew under the watchful eye of mentor Carl Jacobs. “Cody is training to be my replacement when I retire!” he jokes. **This deep bond grew organically, helping to meet Cody’s need to provide a useful, helping hand and keep busy.** Keeping busy and learning new things have helped keep his negative behaviors and outbursts to a minimum.

Kevin and Cody love working with their hands – donning safety goggles and gloves, building things, weed-whacking, cutting grass, you name it! If Carl is working around campus, it’s likely that Kevin and Cody are not far behind. Each afternoon, this duo finds their way to Carl and helps with large and small jobs: hanging TVs, painting, building bed frames or fixing picnic tables and other projects that allow them to use their hands.

Alan and his wife Molly gush with pride over his adjustment and independence, attributing so much of their appreciation to the direct support professionals who provide a nurturing and safe environment and work so hard to keep connected with Cody. The entire family is so happy and proud to call Lakeside his home away from home.

# Proud Partners with Shared Missions



Kessler Foundation, a major nonprofit organization in the field of disability, is a global leader in rehabilitation research that seeks to improve cognition, mobility and long-term outcomes – including employment – for people with neurological disabilities. Kessler Foundation leads the nation in funding innovative programs that expand opportunities for employment for people with disabilities. Kessler Foundation changes the lives of people with disabilities through medical rehabilitation research and funding employment initiatives.

The missions of Kessler Foundation and Bancroft are closely aligned in our shared desire to help people with disabilities realize their best lives. Bancroft received a generous grant from Kessler Foundation to fund Bancroft NeuroRehab’s vocational program. Aimed at helping 80 people recovering from brain injury return to the community through robust volunteer and paid employment opportunities, BNR put this grant to great use by dedicating staff to this effort. As Kari Davidowitz, BNR Certified Occupational Therapist and Certified Brain Injury Specialist shared, “Vocational Services is a full-time job. It’s really needed, it enhances the lives of the individuals we serve, and it can’t be done without charitable funding.”

Kessler Foundation’s grant helped many clients, but one, in particular, shared his story with us. Stephen B. fell from a ladder, shattering his skull and causing three separate brain hemorrhages. After a long bout of rehabilitation, Stephen now works on a horse farm tending to the horses through BNR’s vocational program. As Stephen describes himself, “I’m very goal-oriented. I’m a worker. That’s what I do.” Through the program, he has found a return to his identity and independence and that is the greatest gift of all.

So far, Kessler Foundation has invested close to \$49 million over the past 13 years through grant programs in New Jersey and nationally. Their targeted grantmaking has supported new business ventures, job training and job creation, various sectors and industries, but most importantly, Kessler Foundation is a leading funder of innovative approaches that can effect systemic change by creating genuine economic opportunities for people with disabilities.

These pilots and new models have the potential to change today’s marketplace and can improve the participation rates of people with disabilities in competitive, integrated employment. By leveraging dollars and human capital through partnerships, new ideas from the field rise up to be models for policy change.

**Today, Christopher is a happy 27-year-old who likes listening to music, watching movies and interacting with the other men in his group home.** The Kowals say Christopher had positive behavioral changes almost instantly upon entering Bancroft and he now thrives socializing with the individuals in his residence, the day program and the entire Bancroft team. "Chris lives with a group of guys who are like brothers living their best in a happy, caring atmosphere," said Ellene.

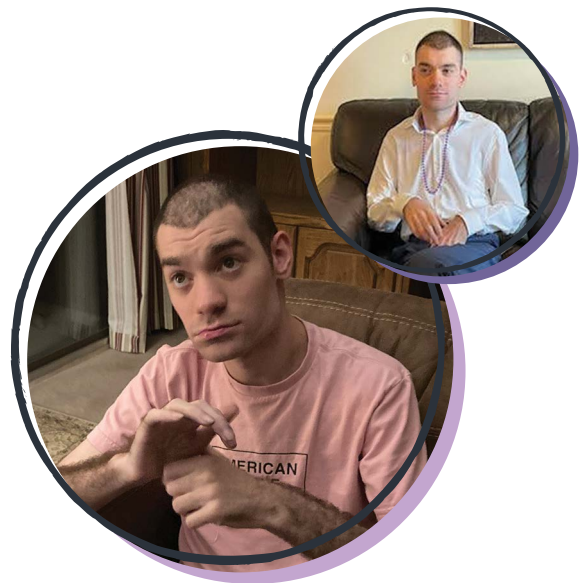
Since coming to Bancroft, all of their lives have changed for the better; Bancroft provides Christopher with the structured care needed to realize his best life. Ellene and Tom also receive the resources, support and communication they need and they continue to feel confident in their decision to trust Bancroft to care for their grandson. From the beginning, the Kowals loved the various opportunities they had to connect with Christopher at Bancroft: holiday parades, classroom activities and other social events.

**While Bancroft provides care for Christopher, Ellene and Tom try to support the organization in any way they can, and their support of Bancroft has been nothing short of inspiring. Joseph “Joe” P. Baranski Jr. had a deep love for his family, friends, food and music – especially live performances, which he attended whenever possible. No matter where Joe went, there was always music, even if he had to sing it himself. Joe was enveloped in music and he shared this love with his family, raising his daughters with his wife of 40 years, Nancy, with music in their hearts. Spending time together at concerts was a regular family pastime and they made sure to see one of their favorites, Tom Petty, as often as they could.



Sadly, Joe passed suddenly in 2020. In lieu of flowers, friends and family members were asked to donate to Bancroft NeuroRehab in Joe’s memory. Nancy, a longtime Bancroft employee, was inspired to create a tribute after the outpouring of support from colleagues and leadership through Joe’s 10-day hospital stay and when her husband passed. It was a reminder that Bancroft was her family too. Combined with her pride to work for a

meaningful organization, supporting Bancroft through this tribute was Nancy’s first thought and her girls agreed, including daughter Crystal, who also works at Bancroft.



Bancroft received incredible support in memory of Joe, and in recognition of his life and legacy, Bancroft added a bench outside of The Resnick Center. At the bench dedication last February, a symbolic card and seed packet was prepared for the event prominently featuring lyrics to Petty’s song *Wildflowers*. The song symbolizes the shared sense of belonging the Baranski family has with music as well as their love for Joe, which they will continue to carry closely in their hearts with them.

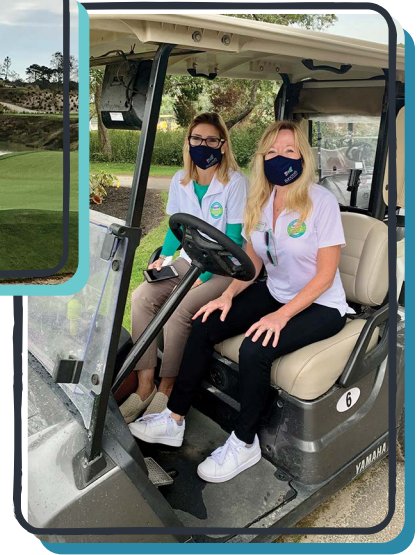
## Tribute Gifts

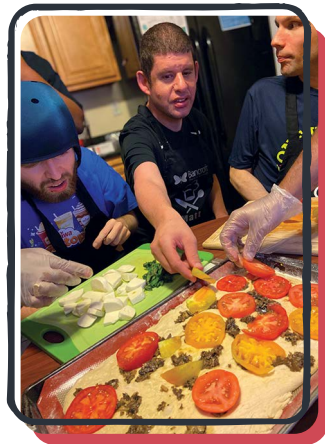

### A New Furry Friend

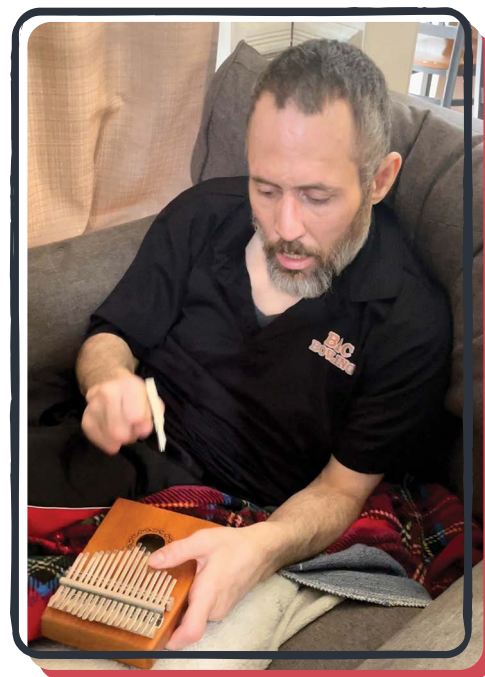

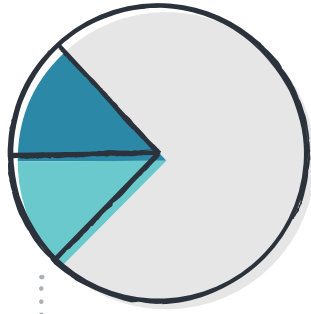

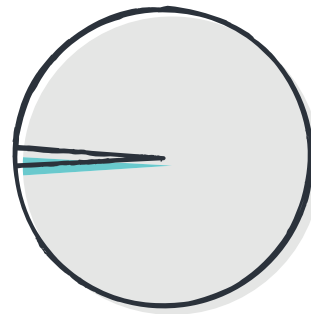
